CCJC Foundation Overview:

- The CCJC Foundation exists to strengthen the outcomes of California Collaborative Justice Courts on the state and local levels through public-private partnerships that meet needs for which there are no other funding sources.
- Under the auspices of the Foundation, Local Fund Advisory Boards participate in the fundraising and oversee the issuance of small grants on behalf of Collaborative Court participants to help them meet the requirements of their judicially-supervised treatment program.
- Local Advisory Board members are individuals with direct knowledge of the types of assistance that can make a difference in a Collaborative Court participant's ability to succeed in their recovery and meet their program requirements.
- The CCJC Foundation is the only statewide Collaborative Justice Courts foundation in the United States. We are a "grassroots" volunteer effort.

The process required to successfully complete a Collaborative Court program has a 75% success rate in rebuilding lives and helping individuals become the people they were meant to be and the capable, caring parents their children merit.

Friends of Drug Court Reclaiming Lives

Giving Back

It is hard to believe the robust person sitting across from me was once a meth addict who 135 pounds weighed. Rudy Hyatt, the Chair of the Friends of Drug Court, is aware of how fortunate he is. "I volunteer for Friends of Drug Court because I did a lot of bad things when I was an addict. NA (Narcotics Anonymous) teaches us to make amends for things we have done. This is just one of the ways I do that – by giving back to the community." Growing up in Willits, Rudy "fell in love with a lady called methamphetamine" when he was a teenager. "It was really fun in the beginning," he told me. "I started selling meth, and soon became my best customer."



The addiction lasted 23 years and landed Rudy in jail repeatedly. What finally changed? "I was tired of being in jail, tired of sticking a needle in my arm. I wanted to quit, but I didn't know how."

Faced with a possible 3-5 year sentence in the State penitentiary, Rudy appealed to Judge Combest to participate in Drug Court, an 18 month program. Initially, participants go to court weekly, to treatment

daily, and to group sessions of NA or AA twice a day. Random drug testing occurs throughout the program. Rudy is grateful to the judge who helped him regain his life. "When Judge Combest granted my request for Drug Court, he bet me \$20 I wouldn't make it. I told him to "put his money where his mouth is" and make it \$50. When I graduated from Drug Court, he handed me a fifty dollar bill."

According to Patricia "Paddy" Michalski, Drug Court administrator, Drug Court works with people with various addictions. "Prescription drug abuse and heroin use are on the rise. Alcohol is the main addiction for some, and is also number 2 or 3 in preferred substances for others."


Paddy notes that 49% Adult Drug Court and 63% of the Family Dependency Court (FDDC) have graduated the program. The results are particularly meaningful for families – 56% of the children of FDDC participants are 5 years of age or younger, and statistics show they have spent less than half of the number of days in foster care as the children of non-drug court participants. But graduation is only the beginning. Rudy says, "At graduation, I always remind people that this isn't the end. They need to keep going to 12-step meetings. It's like walking up a downward escalator – when you stop, you go down."

Dianne Marshall, former Drug Court Administrator, started the Friends of Drug Court Fund at the Community Foundation to provide encouragement to program participants. "When I went through the program there was no help," Rudy told me. "Thanks to Dianne and other donors, Friends of Drug Court helps get people back on their feet." Rudy says his favorite the small grants are the "ones that help people who are getting their children back. We pay for baby clothes, strollers and other such items. It means a lot because it shows that families are coming back together."

<u>Note:</u> The success of the Mendocino County Friends of Drug Court Fund is the inspiration for the CA Collaborative Justice Courts Foundation. Our primary purpose is to make it possible for every community in California that has a Collaborative Court program to be able to have the same success.

In 2013 the Mendocino County Friends of Drug Court funded \$7,500 in participant requests. These requests paid for clothes for work, fees to complete GED certification, books and computers for college, fees to regain driver's licenses, car insurance, security deposits for permanent housing, and children's clothing and furniture.

The CCJC Foundation is "the new kid on the block" in many ways. We continue to build presence and share how we fit into the overall Collaborative Justice Court effort in California. The CCJC Foundation is the only statewide foundation in the country established to serve all the state's Collaborative Justice Court programs. Where it is unethical for judges and justice system employees to request private funding for court programs, the CCJC Foundation and our Local Fund Advisory Boards may do so.

We continue to operate as a volunteer organization that pays for bookkeeping and auditing services. This allows the dollars you donate to be used on behalf of the Local Fund Advisory Boards we serve and the participants they serve.

Our plans for 2014 include securing more matching funds for the various types of Collaborative Justice Court programs, increasing the number of Local Fund Advisory Boards throughout California and securing grant funds towards operational costs and to share with the Advisory Boards.

We hope to secure additional funds so that we may offer matching grants to the full spectrum of Collaborative Courts including Veterans Treatment Courts, Re-Entry Courts (made vital due to mandated prison release programs), Mental Health Courts, Juvenile Drug Courts and other specialty Collaborative Courts.

UPDATE: Goals for 2013

In 2013 the CA Collaborative Justice Courts Foundation will:

▶ **GOAL:** Convene two meetings of our Local Fund Advisory Board members from the various communities, one in late Spring and one in early Fall.

UPDATE: It took us longer than expected to convene these meetings. Nonetheless, we had our first meeting and now have a schedule for 2014 and expect to meet quarterly via conference call. We are also publishing a newsletter for our Local Fund Advisory Board members. Click here to read.

▶ **GOAL:** Seek to find ways to distribute goods to Collaborative Court participants provided by private donors utilizing the oversight of Local Fund Advisory Boards.

UPDATE: We have learned that we may accept equipment such as SCRAM units for Collaborative Court programs for distribution to their participants while the court programs themselves may not. We are also pursuing eyeglasses for participants through Lens Crafters, one of their corporate giving programs. This is an on-going goal.

► **GOAL:** Establish matching funds for two or more of the various types of Collaborative Courts in California.

UPDATE: Thanks to Children and Family Futures and OraSure Technologies we do have two matching funds, one for Family Drug Courts and the other for Adult Drug Courts. We continue to seek additional match fund grants to expand this opportunity further.

▶ **GOAL:** Do more work on the Kresge Foundation Letter of Inquiry to better address the various networks that both California's Collaborative Courts and CCJC Foundation Local Fund Advisory Boards represent.

UPDATE: As we increase the number of Local Fund Advisory Boards, the ethnic and racial diversity of their Board members and the ethnic and racial diversity of the CCJC Foundation's Board of Directors, we increase our eligibility for funding from the Kresge Foundation. Networking and serving diverse communities are two top priorities for the Kresge Foundation.

▶ **GOAL:** Continue to search for foundations that will consider funding our Foundation's unique approach to addressing the needs of individuals whose lives have lead them on the self-destructive path of substance abuse and criminal activity.

UPDATE: We are engaged in the process of researching the Foundation Center's Directory of Grants for Mental Health, Addictions and Crisis Service-2014. We are looking for good matches between their goals and our focus areas for grant funding. We have identified the California Bar Foundation and the Combined Federal Campaign as funding sources we will pursue in 2014.

▶ **GOAL:** Recruit additional Board members who represent needed expertise and California's cultural and ethnic diversity.

UPDATE: This is an on-going process. We are posting volunteer needs with the California AARP's "Possibilities" website. Your referrals of potential Board members and Local Fund Advisory Board members are welcomed.

- Expand the Board of Directors to include additional members of the recovery community




